

Spanish crude oil imports by country

November 2019

Crude oil imports to Spain diminished for the third consecutive month (-10.0% interannual). In the year to date (-2.1%) and rolling year (-1.2%) also decreased.

This month 33 types of crude oil were imported from 19 countries.

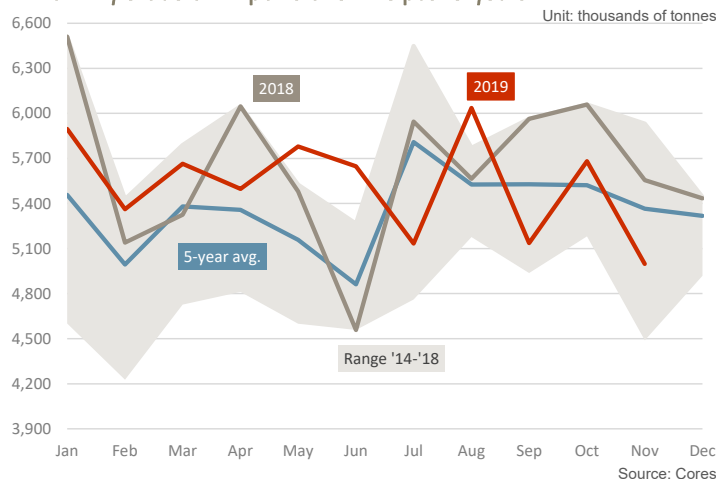
Nigeria (896 kt) remained as the main crude oil provider, despite its registered decrease (-19.4% vs. November 2018). Saudi Arabia (740 kt), with a rise in its supplies (+6.2%), and Mexico (716 kt), which diminished them (-18.3%) were located afterwards. This month, crude oil from Trinidad and Tobago was imported for the first time since January 2017.

Crude oil from the OPEC country members decreased again in November (-6.7% vs. November 2018), although they maintain positive variation rates in the year to date (+2.5%) and rolling year (+4.3%). Imports diminished from Iraq (-45.9%), which registered 316 kt, and from Libya (-15.6%), with 470 kt.

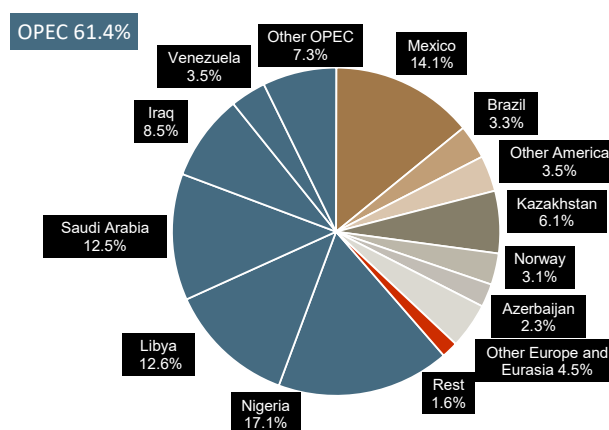
Crude oil imports presented a general decrease by geographical area, except from Central and South America (+6.7%): Europe and Eurasia (-33.9%), Middle East (-17.6%), North America (-4.9%) and Africa (-4.1%), which remained as the main supplying area with a 40.3% of the total.
